

Social Security

What is social security?

• Provides economic security to retirees, disabled persons, and families of retired, disabled or deceased workers

How to obtain:

- Pre-register at <u>www.ssa.gov/ssnumber</u>
- Your first, middle, and last names must be spelled exactly as they are on your passport. Ensure these match your passport when you receive your card

Social Security

Eligibility

- Be in the US for at least 3 business days (Monday-Friday, not including federal holidays such as 4th of July)
- If you are a F-1 or J-1 student you **must have** an oncampus job
 - If you are hired as a Research Assistant or Teaching Assistant, you will need a separate letter from the department hiring you
 - If you have CPT or OPT employment, you can apply for a number **no more that 30 days prior** to your start date
- F-2 visas are **not** eligible to apply
- J-2 visas may apply **after** receiving your Employment Authorization card

Items to Bring with you

- Everyone:
 - Your passport
 - Your I-94 card
 - <u>https://i94.cbp.dhs.gov/I94/ /home</u>to print off your electronic arrival/departure card
- F-1 Visa with on-campus employment:
 - I-20, Employment letter, and completed Memorandum issued by Duke Visa Services
- F-1 Visa with Research or Teaching Assistantship:
 - I-20, completed Memorandum issued by Duke Visa Services and completed Memorandum issued by your Department
- F-1 Visa with CPT:
 - I-20 with employment information (second page) filled out by Duke Visa Services
- F-1 Visa with OPT:
 - EAD cards can also apply for SSN at the same time by indicating on form I-765
- J-1 Visa:
 - o DS-2019 and Memorandum issued by Duke Visa Services
- J-2 Visa:
 - Employment Authorization Card and DS-2019
- H-1B Visa: 0 I-797



Bank Accounts

To open an account

- Passport, visa document (I-20 or DS-2019), and at least \$25 (check with the bank on this amount).
- Social security number will be asked for, but not required. However if you have one, make sure to provide.
 - If you do not have an SSN, you will be asked to fill out a W-8 BEN. This form states you are receiving non-service income and wish to claim exemption from taxes (this is for interest earned on the account).



Bank Accounts

General notes:

- Banks are not open on Sundays or public holidays
- Wiring money from home will require
 - Extra fee (almost always)
 - Names of both banks, bank addresses, and telephone numbers
 - Your account numbers at both banks
 - Receiving bank's routing number and SWIFT code

You will find it almost essential to have a bank account in the USA, unless you are here for a short period of time. We (USA Americans) use debit cards for almost all our purchases these days. We usually carry very little cash on us.

Opening an account

All you need to open a bank account is your passport, a U.S. address and some money to deposit. The bank will ask for your social security number (SSN) but you DO NOT NEED this number to open a bank account. If you are eligible for an SSN, just tell the bank you will give the number to them after you receive it. If you are not eligible for an SSN, that is fine. If you open up an interest-bearing savings account, you are eligible to apply for an Individual Tax Payer Identification Number (ITIN)

Wiring Money

If you want funds transferred electronically from your home to your bank here in the United States, you will need (1) the name of your bank, (2) your bank account number, and (3) your bank's routing number. Each bank charges for wiring funds in and out of the country. Contact the individual banks for fees. Fact Sheets

Driver's License or official State ID card

The DMV is open for walk-ins and appointments. We highly recommend scheduling an appointment online.

The International Student Center will provide **drop off only** transportation to DMV the second Tuesday of every month, leaving from Smith Warehouse.

For Driver's license: first-time Drivers license will require a road test. NC requires you to have driver's insurance before issuing a license, even if you do not own a car yet.

Bring the following items for either Driver's license or State ID card

- Passport
- Visa document (I-20 or DS-2019)
- I-94 card
- Social Security card (if you have one)
- \$5-14 cash, check, or credit/debit→ for Driver's license it is ~\$5.50/year, normally issued for 8 year periods. State ID currently is \$14.
- Proof of Residence-- Bring two (2) items showing you live in NC. This can be a letter from your bank, bill from utility company, copy of lease, etc.

 - Duke shuttle to East Campus can assist with transportation



Utilities and Groceries

Utilities

- Wifi and cable: Spectrum, AT&T, Frontier
- Electricity: Duke Energy (unrelated to the school)
- Water and Gas: Depends on housing situation
 - \circ ie. Campus Walk Apts. \rightarrow National Exemption Service

Traditional Grocery stores (nearby)

- Harris Teeter \rightarrow Two locations on Hillsborough Rd.
- Whole Foods \rightarrow Broad St.
- Food Lion \rightarrow Rebecca Dr.

If mobile transportation is unavailable, grocery chains have direct delivery services available too

Whole Sale/ Bulk Stores

- **Costco** \rightarrow N Pointe Dr (10 min away)
- Sam's Club → Durham-Chapel Hill Blvd. (10 min away)

These require memberships to shop there (monthly or annual payments) but you can be a guest if someone else has a membership

Specialty Grocery stores

- LiMing's \rightarrow 10 minute drive from campus
- **H Mart** \rightarrow ~ 30 minute drive from campus
- Spice Bazaar \rightarrow 10 minute drive from campus (close to LiMing's) (Halal)
- AI-Taiba Halal Market→ 6 minute drive from campus. (Halal)



Cell Phone Providers

Common Providers

Verizon, AT&T, T-Mobile, Spectrum

Plans available

Family, autopay (save more!), or prepaid

AT&T (GSM), Verizon (CDMA), T-Mobile (GSM)

GSM phone \rightarrow can be unlocked to switch between carriers easily

CDMA phone \rightarrow locked to a carrier and won't use a SIM card



Security Deposits

- Security Deposits are extremely common for housing, utilities, and cell phones. These fees are sometimes refundable, and sometimes not. These fees tend to be steeper for international students who have no US credit history
- Housing: Specifically for housing it is **very** common for apartments to require a security deposit equal to one month's rent, in addition to pre-paying both the first and last month's rent upfront before moving in. This can add up quickly!!
- Utilities: can request security deposits of ~\$100 or more per utility



Taxes Duke Corporate Payroll Services

Non-Compensation/ Scholarship Status:

US Citizens, permanent residents and residents:

- Select to submit IRS form W-4 and NC Department of Revenue form NC-4
- Will receive IRS form 1099

Foreign Nationals:

- Depends on the circumstances of the individual trainee:
 - Newly arrived
 - Likely will receive a 1042S form
 - Has been back and forth to the USA previously
 - May be eligible for 1099 or "courtesy letter" tax forms

- One semester of TA-ing
 - Normally TA Principles of Immunology as a cohort fall of 2nd year
 - Additional TA-ing can be done for stipend supplement

Useful Websites for Duke Students

- <u>Duke email</u>: Most critical information is conveyed through email
- <u>DukeHub</u>: Class enrollment, financials, health insurance enrollment. Twice a year DukeHub also will require verification of basic info to release a block on registration, takes about 5 minutes or less
- <u>Sakai/Canvas</u>: Manage course info and homework
- <u>Duke list</u>: Duke students/faculty can post information about housing, items for sale, etc
- <u>Duke T3</u>: Keep track of academic records \rightarrow Used to record rotations, prelim, committee meetings, and defense
- <u>Duke OIT</u>: Download free software and help with connection problems
- <u>**IHouse</u>**: Provide international student support and visa service</u>
 - Great list of "how to" resources
- <u>DukeBox</u>: A cloud-storage based system, akin to Dropbox. Resources are sometimes shared via DukeBox.



US Holidays

Federal holidays: banks, government agencies, and several other institutions may be closed

New Year's Eve and Day	First and last days of the year are federal holidays.
Martin Luther King Jr	Federal holiday celebrating the birthday of <u>Martin Luther King Jr</u> , a civil rights activist who fought for racial equality in the 1960s and was assassinated. Observed on the 3rd Monday of January.
Memorial Day	Day of remembrance for honoring US military who died in service. Federal holiday that is observed on the last Monday in May.
Juneteenth	Recently declared a federal holiday, Juneteenth is celebrated on June 19th, the anniversary of when <u>enslaved people</u> in Texas were finally told they were freed, two and a half years after the Emancipation Proclamation of 1863 declared all enslaved people in the <u>rebelling Confederate States</u> free.
July 4th	Anniversary of the Declaration of Independence, when the US declared itself free of Britain. Also called "Independence Day", it is a federal holiday.
Labor Day	Federal holiday that honors the US labor movement and the works and contributions of laborers to the development of the US. Celebrated the first Monday in September.
Veteran's Day	Federal holiday honoring all who have served in the US military. Observed on November 11th each year. Duke does not have this as a holiday.
Thanksgiving	Observed the fourth Thursday in November, Thanksgiving is meant to be a day of thanks and observance. However it is also considered a <u>National Day of Mourning</u> for many Native Americans in remembrance of the genocide of Native Americans by colonists. The day after Thanksgiving is also considered a federal holiday and is called Black Friday this is associated with massive sales and the official beginning of the Christmas season.
Christmas	Christmas Eve (December 24th) and Christmas (December 25th) are both federal holidays. It is quite standard for people to take off the entire week between Christmas and New Year's.
